Transfer of Equity Shares to Investor Education and Protection Fund (IEPF) during the year 2022-23:

1. The Investor Education and Protection Fund Authority (Accounting, Audit Transfer and Refund) Rules 2016, inter alia provide for transfer of all shares in respect of which dividend remained unclaimed for 7 (Seven) consecutive years or more, in favour of the Investor Education and Protection Fund Authority (IEPF).
