Consequent to the aforesaid transfers, as on December 31, 2025, Mrs. Ratna Manikyamba Katneni and Mr. Jitendra Prasad Katneni are each holding 37,500 shares, while Mr. Katneni Sarath Babu and Mr. Katneni Uma Maheswara Rao are holding nil shares.
